INAUGURAL AND ORGANIZATIONAL MEETING

The inaugural meeting will be the first regular board meeting of the Turtle Mountain School Division after an election as required by the Public Schools Act. The organizational meeting of the Turtle Mountain School Division will be the first regular board meeting in September on an annual basis in years where there is no inaugural meeting held. The inaugural or organizational meeting will elect the Board Chairperson, Vice-Chairperson, Standing Committees, and appoint representatives to other committees as deemed necessary by the Board.

At the inaugural or organizational meeting of the Board of Trustees of the Division, the trustees shall by written ballot nominate and elect from among themselves a Chairperson and a Vice-Chairperson. The Secretary/Treasurer shall preside at the election or, if he/she is not present, the trustees shall select one of themselves to preside at the election, and the member so selected may vote on the election. A majority of the Board members present is needed to declare the chairperson and vice-chairperson elect.
