SECURITY AGREEMENT

THIS AGREEMENT made in triplicate this -15th-day of June - A.D.2022 ---

BETWEEN:
Her Majesty the Queen in right of the Province of Manitoba, represented herein by the Minister of Education and Early Childhood Learning
(hereinafter called "the minister")
-and
Turtle Mountain School Division
(hereinafter called "the division") OF THE SECOND PART.
WHEREAS the division proposes to issue a debenture or a promissory note (hereinafter called "the Security") securing a total principal sum of ———————————————————————————————————
(hereinafter called "the accommodation")
AND WHEREAS the minister is satisfied of the need of the division for the accommodation;
AND WHEREAS the division has requested the minister to deduct from the total of all grants due to the division from the minister, in the years hereinafter mentioned, to the extent of the total of such grants, the amounts hereinafter mentioned for the purpose of paying principal and interest of the said Security; AND WHEREAS the minister, subject to the execution of this agreement by the division, agrees to deduct from the total of all grants due to the division from the minister, in the years hereinafter mentioned, to the extent of such grants, the amounts hereinafter set out and apply or order the application thereof in payment of principal and interest due on the Security, sufficient to make the payment of principal and interest due in those years.
WITNESSETH:

The division will provide in whole or in part the accommodation at an estimated sum of —— \$75,000 —— including the cost of land, buildings, equipment, tabour, material, fees, commissions, exchange, discount and all other charges of any nature whatsoever in connection with or arising out of the issue and sale of the Security and provision of the accommodation."
- The division undertakes that upon completion of the accommodation, and upon further issuance of the Security, all accounts in connection therewith shall be duly paid.
- 4. The division will include in its budget in each year hereinafter mentioned in addition to the sums required for all other purposes of the division, the sum required in that year for the payment of principal and interest under the Security due in that year.

- 5. In each year set out in the left hand column of the following table, the minister shall deduct from the grants payable to the division by the minister in that year to the extent of the total of all grants due to the division from the minister in that year, the sum set out opposite that year in the second column of the within table and pay or apply in payment of the principal and interest due on the said Security from time to time amounts required to make payment of the principal and interest payable in respect of the said Security from time to time to the extent of the said grants, or hold the amount of the said grants in trust for the purpose of paying or applying it in payment of the principal and interest due on the said Security from time to time.
- 6. If, after the whole of the principal and interest due on the said Security is paid and satisfied, the minister continues to hold any monies deducted from the grants payable to the division under this agreement, the minister will pay the amount so held to the division.
